# As-Built Plan Application Instructions

## As-Built Plan Overview

As-Built Plans are required to:

- Determine project is compliant with the Planning Board Approval.
- Issue a Certificate of Occupancy.
- Confirm project is completed as approved by the Planning Board.
- Release performance escrow money.

If the applicant seeks a Certificate of Occupancy prior to completion of all improvements, a Provisional As-Built Plan must be submitted documenting the current conditions of the project. A Final As-Built Plan is still required when the project is complete.

## Required Documents

The following required documents are submitted to the Planning Department.

### Note:

- As-Built plans must include at least 2 points showing a northing and easting in NH State Plane North American Datum of 1983 (NAD 83) coordinates.
- As-Built elevations must be referenced in North American Vertical Datum of 1988 (NAVD 88).
- The CAD files must use the same coordinate systems listed above, (NAD 83 and NAVD 88).

## As-Built Plan Review Process

- Applicant submits the required documents to the Planning Department.
- The Planning Department:
  - Distributes relevant plan set documents to City departments.
  - Uploads records to OpenGov.

- c. Creates As-Built Plan Review task in OpenGov.
- 3. As-Built Plans Review:
  - a. Planning Department:
    - i. Reviews the As-Built Plans against the certified Final Plans submitted as part of project approval.
    - ii. Enters findings on the OpenGov platform.
  - b. Department of Public Works:
    - i. Confirms the As-Built plans contain all necessary infrastructure information.
    - ii. Conducts a site inspection to confirm site conditions accurately reflect the plan.
  - c. GIS Section:
    - i. Confirms the CAD drawings meet format requirements and contain all necessary information.
    - ii. Enters findings on the OpenGov platform.
  - d. Fire Department:
    - i. Confirms the As-Built Plans address any emergency services concerns.
    - ii. Enters findings on the OpenGov platform.
- 4. As-Built Plan Finalization.

Planning Department issues a Notice of Decision. (Any additional actions required of the applicant are listed in the notice.)
