City Charter, Section 74

General Ordinance § 7-28, 7-78

9 Member Board: 7 Regular Members; City Manager or Designee [Ex-officio]; Council Member [Ex-officio]

**Regular and Alternate Members:** Mayor nominates subject to confirmation by Council; after Mayor nominates, any Councilor can nominate. Ballot vote required; 3 Year Terms.

City Manager's Designee must be approved by Council.

City Council elects the Regular and Alternate Council Members: \*\* their terms are the same as their official tenures on Council.

All vacancies must be filled for unexpired terms; regular and alternate member vacancies filled in accordance with Chapter § 7-78 of General Ordinances.

RSA 673:6 allows "up to five alternate members"; however Chapter § 7-28 of the General Ordinances provides for five alternate members only. All members of the Planning Board must be residents of Rochester-RSA 673.1.

§ 158-3 B **Term** and Officers of Commission. The terms of the City Council and School Board Commissioners shall be commensurate with their terms of service on their respective boards. Commencing January, 2016, the eleven (11) Commissioners shall be appointed for one (1), two (2) and three (3) year terms as determined by the City Council. Thereafter, all appointments and reappointments shall be for a term of three (3) years. The Mayor shall appoint the chairman, the commission shall, from its own members, elect a secretary, and other necessary officers to serve for one year or until their successors are elected. *Mayoral Nomination /Confirm by City Council – Chair – no specific regulations–appoint each chair for term of membership.*

City Charter, Section 74:

Mayor nominates, subject to confirmation by Council, after Mayor nominates, any Councilor can nominate. Ballot vote required. 3 Year Term.

Ordinances § 7.29

"The Board of Trustees of Trust Funds shall consist of five members representing an increase from the traditional three members. The two additional members shall be appointed by the Mayor in accordance with the provisions of Section 74 of the Rochester City Charter with one Trustee appointed for a one-year term and one Trustee appointed for a two-year term. Thereafter, one Trustee shall be appointed annually in January by the Mayor in accordance with the provisions of Section 74 of the Rochester City Charter for a term of three years to replace those whose terms expire, and vacancies occurring in such office shall be filled in like manner for the unexpired term. The Trustees shall organize annually by electing one of their number treasurer, who shall keep the records and books of the Trustees." Board elects it own Treasurer annually, Ordinance § 7.29
