**RESOLUTION AUTHORIZING SUPPLEMENTAL APPROPRIATION**  
**FOR THE PURCHASE OF THE HOPE FARM EASEMENT**

**BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF ROCHESTER, AS FOLLOWS:**

That the sum of Ten Thousand Dollars (\$10,000.00) be, and hereby is, appropriated as a supplemental appropriation to capital improvements budget of the City of Rochester Conservation Commission for the purpose of providing funds necessary to pay costs and/or expenditures with respect to the purchase of the so-called Hope Farm Easement, and provided further that funds for such supplemental appropriation shall be derived in their entirety from the so-called Conservation Fund of the City of Rochester.

**LEGAL AUTHORITY**

Chapter 11, Section 21 of the City of Rochester General Ordinances and as authorized by RSA 36-A:4.

**SUMMARY STATEMENT**

In January 2014 the City Council approved Conservation Commission's (Con Com) request to appropriate \$189,999.00 to purchase and close-on an easement at Hope Farm (36 Peaslee Rd, Map/Lot 253/49). This \$189,999.00 figure was the amount estimated by a land acquisition consultant hired by Con Com. Unfortunately this consultant severely underestimated the legal and professional costs associated with this project, and also failed to provide adequate professional services.

Because Con Com was forced to hire another professional, and because the original estimate was underbudget, additional funds, up to \$10,000.00, above the appropriated \$189,999.00 are needed to finish this project.

**RECOMMENDED ACTION**

Vote in the affirmative to appropriate additional funds to close on Hope Farm conservation easement.

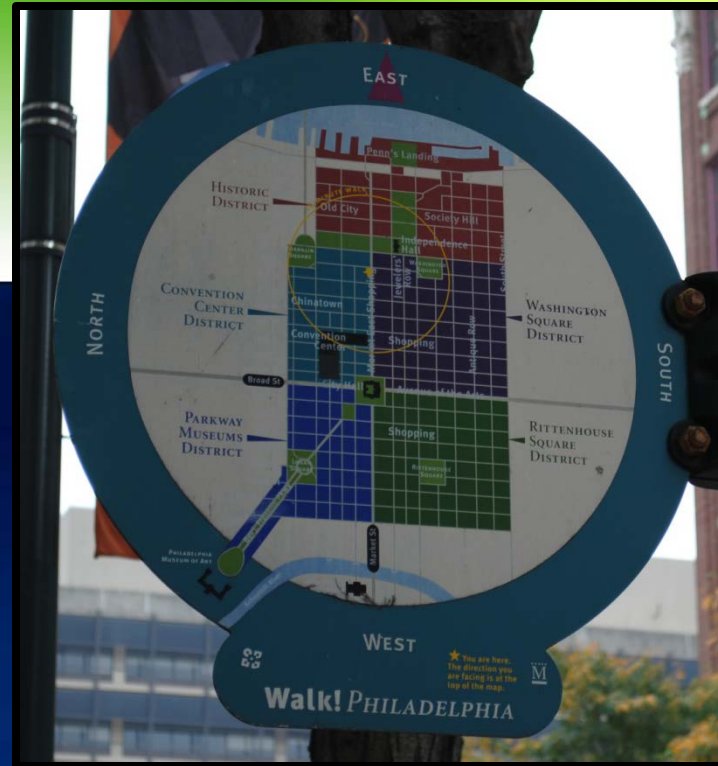
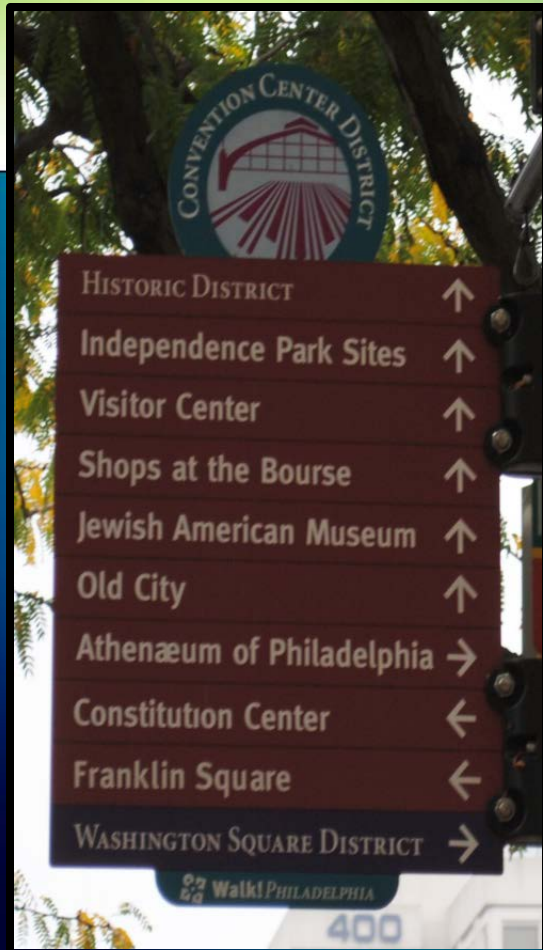

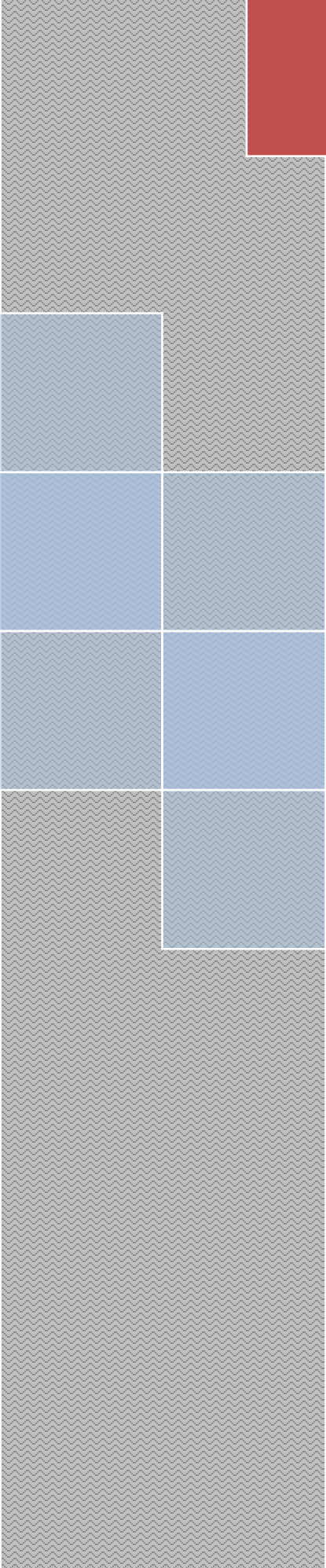
