Description of matters discussed, and final decisions made:

St. Elizabeth Seton School Property, 16 Bridge Street

Director Scala presented the Council with his proposal for the City to make an offer to purchase the so-called St. Elizabeth Seton School Property (the "Property"). Councilor Sullivan asked if the City was only purchaser to resell to a developer. Scala said yes, that this would allow the City to control the development of this important downtown parcel, particularly through the RFP process. Fontneau wanted to know if the City had knowledge about the nature of the potential purchaser. Scala explained what the City had learned about the purchaser and that it was his

opinion that the potential purchaser did not have the financial capacity to fully develop the parcel. Scala said this potential purchaser has not contacted the Church since he signed a Letter of Intent and he did not follow up with Scala on a scheduled meeting.

Councilor Lawrence asked if the potential developers with capacity would be the bidders on an potential RFP. Scala stated that that would be his plan and that he has had initial discussions with those developers about working with the City. Councilor Herman wants to buy the parcel and turn it over to SOS Recovery to give rehabilitation and housing to the homeless. Scala said that he was not aware if that use would be allowed by zoning in that district.

Director Sullivan explained the financing aspects to the Council including the use of ARPA funds in order to secure a commitment for affordable housing units in the Property.

Mayor Callaghan, in response to Councilor Herman, stated that he has spoken with social services networks about the Property and that if would be too expensive for them to convert it to their uses. The Mayor then asked how the money for the State works for demolition and remediation. Scala stated that the State standards just changed that would allow the City to receive even more than the originally anticipated \$500k grant. Callaghan stated that he believed that \$750k is small price to pay to get 10-12 affordable housing units.


Fontneau said this is a critical piece of the City's downtown redevelopment and it is imperative that the City control is development to best that it can do.

Councilor Turner asked how long it might take to resell the property. Scala stated that based on past and current experience, he envisions a signed P & S within months. Councilor Richardson asked how the Riverwalk Easement would work. Scala stated that the City would reserve an easement in perpetuity in the deed granted to the subsequent purchasers.

In response to a question from Councilor Creteau, Director Sullivan explained how a subsequent purchase would work in terms of "passing through" the ARPA money. In response to a question

from Councilor Karolian, Scala explained how the City pays a premium for properties in order to invest in our downtown.
