# Description of matters discussed, and final decisions made:

## Potential Sites for the City to Purchase for a new schoolhouse building

Superintendent Repucci provided an overview of where the School Department is on its need for property to construct a new schoolhouse building. The School Department has focused on 753 Salmon Falls Road.

Councilor Beaudoin provided personal insight on the proposed site and stated that it is extremely wet and mostly unusable without significant financial costs to the builder.

Councilor Fontineau provided personal insight on the proposed site from his time on the Planning Board and a project that did not go forward because it was cost prohibitive.

Mr. Totty provided information on the wetlands issue. He stated that experts hired by the School state that 9.2 contiguous acres of the parcel are dry, buildable upland.

Councilors expressed concern about bottleneck traffic on Salmon Falls Road.

Councilor Beaudoin asked about subdividing off the unusable portion. Attorney Grossman stated that the price the City is willing to pay for the property will factor in the nearly 30 acres of land that is not usable for School purposes.

Councilor Gray suggested that the City wait until April to get a better idea of the extent of the

wetlands on the property.

Chairman Lynch and Superintendent Repucci stated that the School Department is on a constricted time schedule to obtain \$20 million in State funding for the project. The entire application must be submitted by May 1, 2023. School Department cannot submit the application without owning the parcel.

Attorney Grossman provided the Council with his intent as to the terms of any potential P & S, essentially most favorable to the City.

Vice Chair Harrington explained the amount of time and effort already expended by the School Department on this issue and the need to act quickly to obtain the funding.

Chair Lynch explained the criteria used by the School Department to evaluate the efficacy of all the potential sites and how it landed on 753 Salmon Falls Road.

Councilor Hamman asked how the School Department was going to avoid the mistakes made during the construction of the middle school. Chair Lynch explained that the School Department understood and admits to past mistakes and approached this process with those concerns at the forefront.
