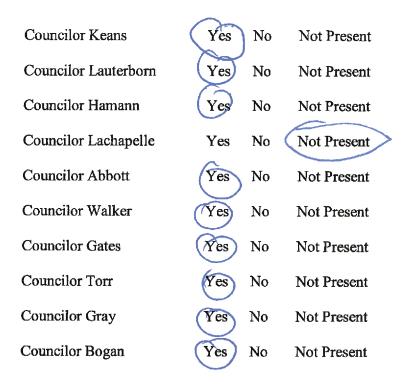

Description of matters discussed, and final decisions made:

Scala presented updates on potential developments of three City owned properties:

1) 19 Main Street: Scala reiterated that a potential buyer wanted to purchase the old East Rochester Firehouse for a residence and a work space. Scala said the buyer is motivated and the project is feasible. Unanimous Council decision: Make the public aware the building is for sale. Cox stated he will make the information public and create signage on site.

- 2) 40 Elmo Lane: Scala reported interactions with a potential buyer from Portsmouth. The buyer wants to move his entire operation to Rochester, but the buyer wants to deed back most of the parcel to the City in exchange for the City paying to install water/sewer and fro upgrading the road from a Class VI road to current City standard. The buyer also asked for a TIF to be created around the property. Unanimous Council decision: Reject the offer.
- 3) Index Packaging: Scala provided an update on the City's potential sale of land on Innovation Drive to Index Packing. It appears Index may build two buildings: one 120,000 square foot building for them and one 70,000 square foot building to lease to Safran. Sullivan discussed the impact these potential developments could have on the TIF district and its ability to fund the water loop project. No action requests were made of the Council.

Devine provided the Council with an update on three downtown properties:

1) Salinger Building/Scenic Theatre: Devine discussed his many meetings with various developers and architects. Devine stated he has had extensive discussions with developer Eric Chinburg.

Devine stated that in order to move forward with Chinburg, the City would need to hire an architect to create as-builts, clean out and selectively demo portions of the buildings, and replace the roof on the Scenic Theatre. Councilor Hutchinson inquired about how many residential units the building would have. Devine stated we would know after we received the as-builts. Council voted 11-1 (Torr against): Move forward with the as-builts and with negotiations with Chinburg.

2) 55 North Main Street: Devine presented a proposal to create a Main Street Market within the building as a municipal enterprise. He explained that the Main Street Market would be in the vein of Quincy Market and Reading Terminal. Devine stated that the City would lease the building from the current owner, fund the rehabilitation, and then contract out the management of the property to a third party. The Mayor spoke about her previous dealings with the owner and her vision for the market. Sullivan stated that with Council approval he will begin a financial

feasibility analysis of the proposal. Mayor spoke on behalf of this proposal specifically and downtown revitalization in general. Mayor feels this project is a good use of the fund balance. Councilor Abbott spoke positively about his experiences in Dover with this type of rehabilitation. Councilor Hutchinson asked about affordable housing. Councilor Lauterborn spoke in support of both projects. CM Cox stated he has the money available right now to move forward with as-builts for the Main Street Market. Unanimous Council decision: Move forward with the as-builts and continue negotiating the project.
