CONSTRUCTION PHASING:

1. **THE PROSECUTION'S CASE.** *State v. Williams*, 1997 WL 1000000 (S.D. Cal. 1997). The prosecution's case is based on the fact that the defendant, Williams, was found in possession of a large quantity of marijuana. The prosecution argues that Williams was in possession of the marijuana at the time of the search and that he was aware of its presence.
2. **THE DEFENSE'S CASE.** The defense argues that Williams was not in possession of the marijuana at the time of the search. They claim that the marijuana was found in a common area and that Williams was not aware of its presence.
3. **THE COURT'S FINDINGS.** The court found in favor of the defense. It concluded that Williams was not in possession of the marijuana at the time of the search.
4. **THE COURT'S REASONING.** The court reasoned that the prosecution failed to prove its case beyond a reasonable doubt. It found that the evidence was circumstantial and that there was a reasonable doubt as to Williams' guilt.
5. **THE COURT'S CONCLUSION.** The court concluded that Williams was not guilty of the crime charged and that he should be acquitted.

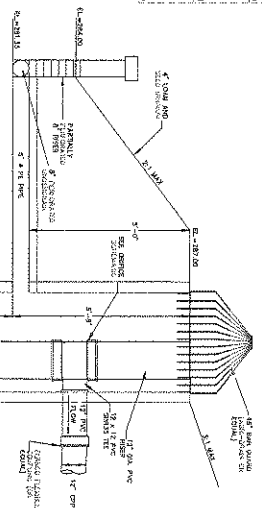
### GRAVEL WETLAND MATERIALS CROSS-SECTION

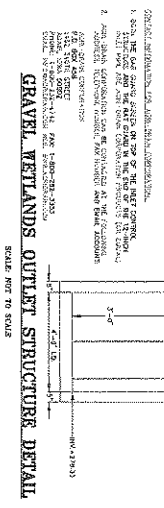
### GRAVEL WETLAND OFFICE SCHEMATIC

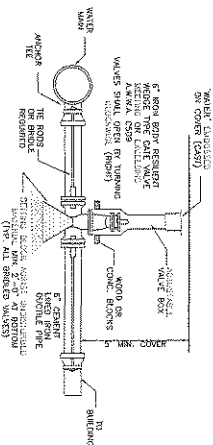
### TYPICAL AT NON BRIDLED VALVE

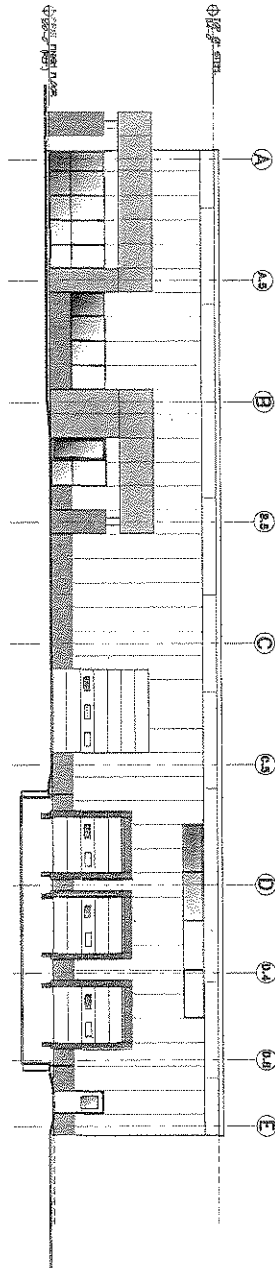

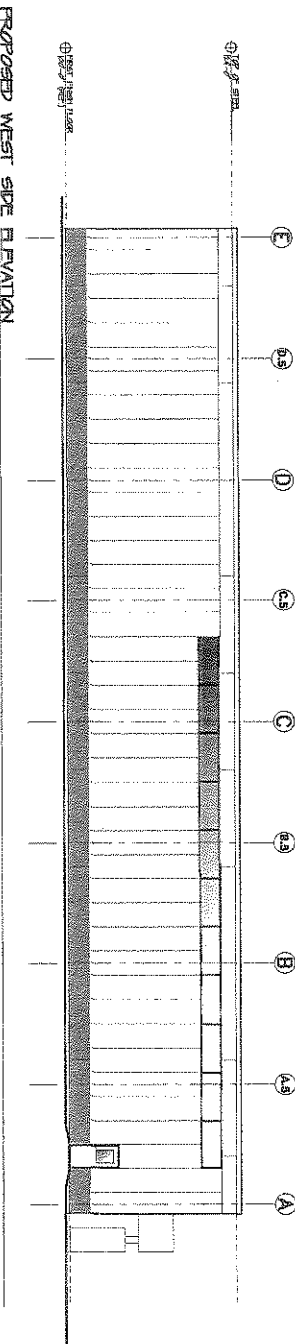
PROPOSED SOUTH ELEVATION



PROPOSED EAST SIDE ELEVATION

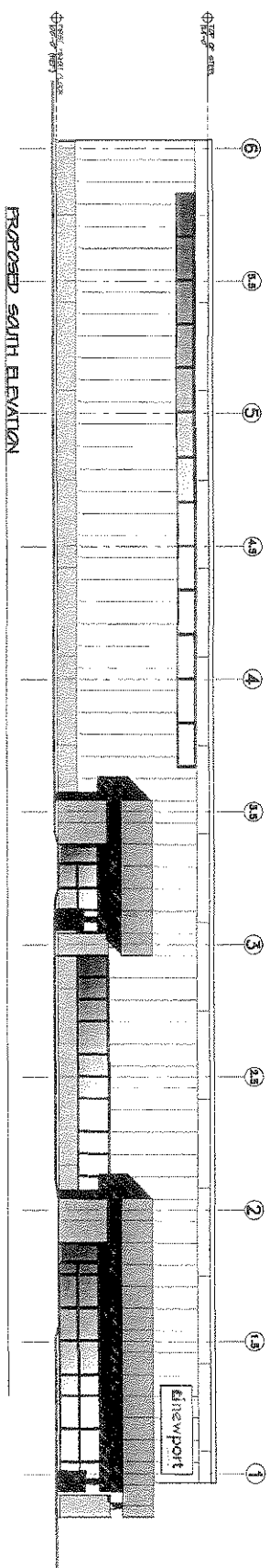


PROPOSED NORTH ELEVATION

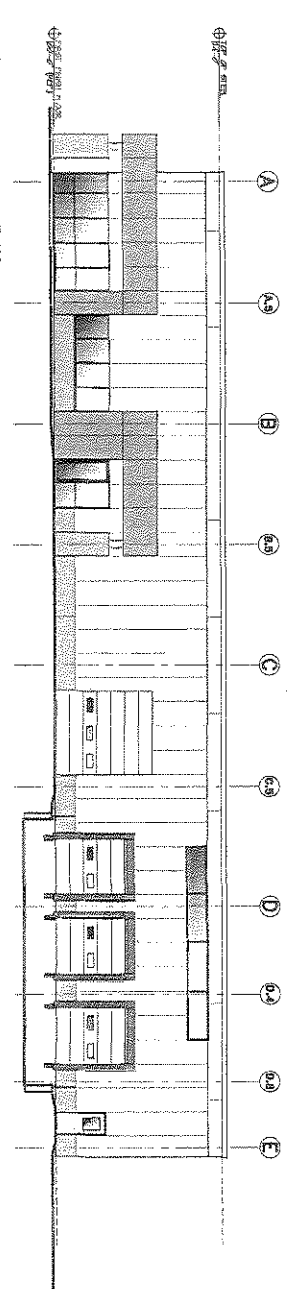


PROPOSED WEST SIDE ELEVATION

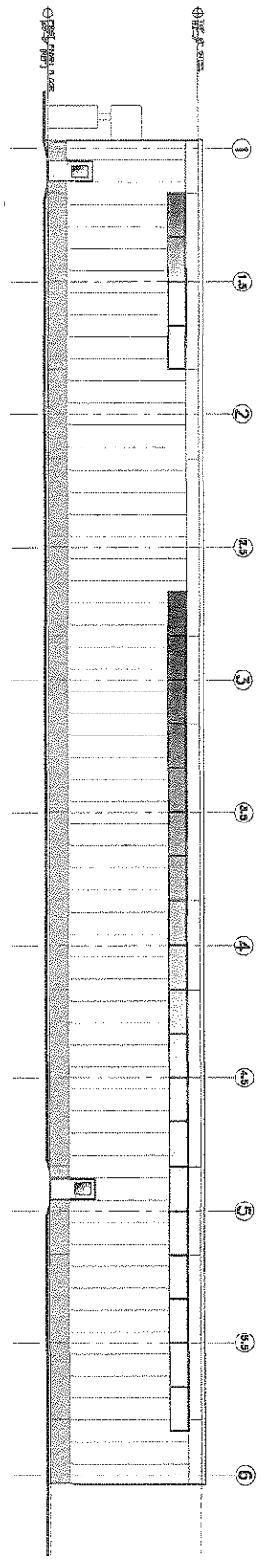

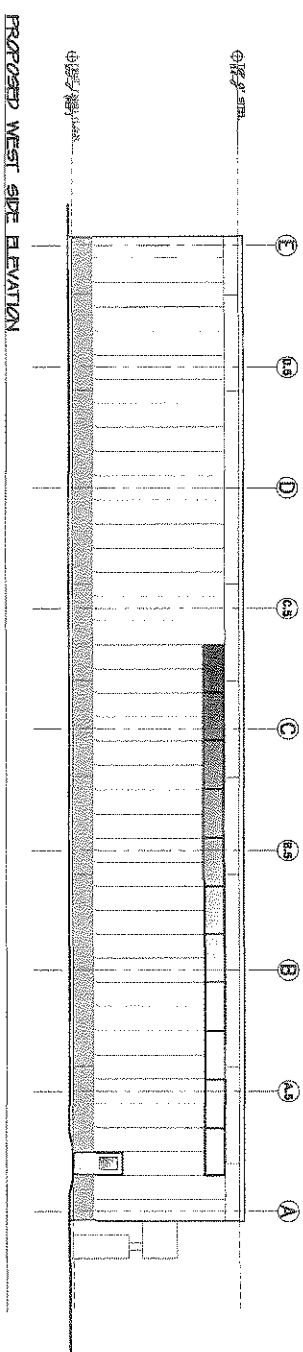
PROPOSED SOUTH ELEVATION
