Separate sealed BIDS for the construction of Contract No. 07-12 Phase I – Gravity Sewer & Force Main of the Rochester Hill Pump Station, Force Main and Gravity Sewer Project will be received by The City of Rochester at City Hall Council Chambers, 31 Wakefield Street, Rochester, NH 03867 until **2:30 PM Thursday September 21, 2006** and then at said office publicly opened and read aloud. The Phase I project consists in the construction of approximately 3,490 LF of 8-inch diameter SDR 35 PVC gravity sewer; 55 LF of 6-inch diameter forcemain installed in a 12-inch diameter sleeve; and 555 LF of 6-inch diameter HDPE force main result in a total length of 4,100 LF.

1. Completion time for the project will be calculated as calendar days from the date specified in the "Notice to Proceed" as follows:
 - Substantial Completion: 120 calendar days, not including days for a negotiated winter shutdown.
 - Contract (Final) Completion: 150 calendar days, not including days for a negotiated winter shutdown.
2. Liquidated damages will be in the amount of \$ 500.00 for each calendar day of delay from the date established for substantial completion and \$ 750.00 for each calendar day of delay from the date established for contract completion.
2. Each General Bid shall be accompanied by a bid security in the amount of 5% of the Total Bid Price.
3. The successful bidder must furnish 100% Performance and Payment Bonds and will be required to execute the Contract Agreement within 10 days following notification of the acceptance of its bid.
