Hi Brian

I received a request from Linda Casey to provide the info you needed for Bid #09-38. I think I have what you need, but please review the figures and let me know if it doesn't look correct.

We have 770 full & part time employees who are benefit eligible (615 f/t & 155 p/t) all of whom could have retiree benefits, if they choose.

There are 195 retirees & dependents with medical plans. There are 159 retirees & dependents on dental plans. Very few of the dental plan subscribers are not on the medical.

We have no figures on retirees who may have converted their life insurance to personal plans.

The bulk of the retirees fall into only 2 medical plans - Blue Choice and Medicomp 3. There are only two dental plans represented.

Unless eligible for NHRS subsidy, the retirees pay 100% of the cost of medical and, since subsidy does not apply to dental, 100% of dental.

Sorry for the delay. Our answers are as follows:

- 1. Active employees 178 employees as of May 19, 2009.
- 2. Current retirees/spouses/dependents are approximately 62 as of May 19, 2009.
- 3. Retirees are eligible for medical and dental coverage only.
- 4. There are 6 plans that cover retirees; two are Medicare supplemental plans.
