Boat launches were also discussed and the potential locations would Hinsdale Drive near the athetlic fields, outside of the Rivewalk district at near Little Falls Bridge Road. The committee will look further into locations and access more towards the downtown area near restaurants and shops.

Corey and Sandy were going to meet with Fish and Game to discuss funding a handicap access launch and pier, neither was at the meeting.

The group needs to find out whom to contact to see if it's possible to clear the river of debris for ease of access to float/paddle down the river. It was mentioned the group should contact Strafford River Conservancy to see if they might have the answer.
