C. <u>DISCUSSION – Grant opportunity from Strafford County Board of Realtors</u>

Barbara Murphy presented the Strafford County Board of Realtors grant program for outdoor community projects, managed through National Association of Realtors. She will provide documentation of the grant requirements to Jenn. Given the information presented, the committee expressed interest. **Jenn** will review the document. If it appears suitable for Riverwalk, she will write a letter of interest to the SCBR.

D. DISCUSSION – Potential project

Of the four areas under consideration—an overlook at the dam near Duval Park, a pocket park behind the Gaffney house, pocket parks within Dominicus Hanson Park, and Water Street—the best project to target for the next effort would be enhancement of the handicap-accessible outdoor classroom in Hanson Pines. **Jenn** will check with the Director of Parks on the possibility of a structure of some sort in the park.

An overlook at the dam is a desirable project because it would be downtown. **Jenn** will ask the Department of Public Works for a back-of-the-envelope estimate of cost. **Suzie** and **Esther** will work to keep this project moving forward.

The big idea of Riverwalk, to provide a walk along the Cocheco, remains; but the committee recognizes the challenges and the need for taking a long view, while watching for opportunities to bring it to reality.

E. <u>DISCUSSION – Kayak launch update</u>

Jenn reported that the launch has been removed and put into storage. DPW and the Recreation Department collaborated in managing the take-out. It will remain in storage until May 15th.

F. DISCUSSION – Plague for past chair

David will present this plaque and the city's appreciation of service on some afternoon soon at Factory Court.

G. <u>DISCUSSION - Next meeting</u>

Rather than meet on Christmas Eve, we will meet two days earlier on Tuesday, December 22.
