There will be a Public Safety Committee Meeting held on April 21, 2021 at 6PM. This meeting will be broadcast on Cable 26 for Atlantic Broadband customers, and on channel 22 for Comcast customers, and the meeting will stream online at City's website WWW.Rochesternh.net.

Good Evening, as Chairperson of the Public Safety Committee, I am declaring that an emergency exists and I am invoking the provisions of RSA 91-A:2, III (b). Federal, state, and local officials have determined that gatherings of 10 or more people pose a substantial risk to our community in its continuing efforts to combat the spread of COVID-19. In concurring with their determination, I also find that this meeting is imperative to the continued operation of City government and services, which are vital to public safety and confidence during this emergency. As such, this meeting may be conducted without a quorum of this body physically present in the same location.

- a.) <u>Public Input:</u> Due to the ongoing situation with COVID-19, the City of Rochester will be taking extra steps to allow for public input, while still ensuring participant safety and social distancing. In lieu of attending the meeting, those wishing to share comments, with the Public Safety Committee are encouraged to do so by the following methods:

In an effort to adhere to CDC guidelines: enter only at the front Wakefield Street entrance and exit on the side closest to the police department and adhere to 6-foot social distancing while inside. Hand sanitizer and facemasks will be available at the Wakefield Street entrance. Participants will be admitted into Council Chambers one at a time to speak, and will exit directly thereafter. Please note; the seating in Council Chambers will not be available for the public during meetings.

Dear Safety Committee,

Our street, Nottingham Lane is in the Ward 1 district. The road contains 12 single family homes and is just outside of the Rochester city limits. There is presently no posted speed limit sign. Our street is a non through way, straight and relatively short distance with a grass filled common area inside the roundabout at the very end of the cul-de-sac.

Although there are some instances where drivers who are unfamiliar with the street drive to fast, our main concern lies with one neighbor and her newly licensed teenage son regarding the speed in which they are driving. This has been an ongoing concern for a few years. They have both been asked numerous times by street residents to slow their speed to an appropriate level based on the surroundings. Unfortunately, the police have been called several times due to her lack of cooperation and common sense.

The driving poses a great danger to the residents and twenty plus young children (under 10) who live and play here.

We would collectively like to address the issue as the warmer weather approaches and before it escalates further or results in a tragedy. Please consider our request to add an appropriate speed limit, possibly 15mph based on size of street and demographics of the residents and enforce it with the appropriate signage.

Attached we have signatures from each of the other 11 households all in agreement that this matter should be addressed and is of great concern.

Good morning,

My name is Rebecca Behr, I reside at 905 Portland st. I am writing to you to inform you of road dangers in my area. I have owned my house the last 5 years and before that lived in the same neighbor for several years. I would like to encourage you to brainstorm ideas to make the curve at Portland, pearl and cocheco safer. Over the time I have lived here I personally have witnessed at least 10 accidents of people hitting the pole in front of my house. I have also witnessed several vehicles

driving on the sidewalk after not following the turn of the road. Last year when they were repaving the sidewalks a vehicle went onto the sidewalk and struck cement and had to have SUR come out to remove the cement from around the vehicle in order to tow the vehicle out. Monday night someone drove on the sidewalk and smashed into the trash bins and pushed them approx 75ft down the road. On multiple occasions the trash bins have been the thing someone hits and realizes they aren't on the road, keeping them from hitting my house. I have had my trash bin(on the side of sidewalk) hit my house several times from people smashing into them at high speeds.

When you include people hitting the pole in front of my house and others hitting trash cans, driving up on the curb and other non reportable offenses the number is outrageous. I have small children, and there are always kids, families and others walking down the sidewalk. My concern is that one of these times it won't be a pole or a trash bin getting hit by drivers missing the curve.

I am not sure if/any options there are available to keep drivers on the roads but I did want to bring that area and my concerns to your attention. Perhaps add speed bumps to encourage people to slow down, it's a highly traveled area as its right next to Nancy Loud School, I'm sure the crossing guards can contest to the fact many people fly down the road and that one particular curve I am concerned about.

He stated that the deaf person (named Lou) hasn't lived at 20 Willey Street since about 15 years ago. The people who required the sign was the neighbors who lived at 18 Willey Street (Hoover).

There is 1 sign coming in from North Main Street on the right in front of 14 Willey Street and the other sign is somewhat near 28 Willey Street coming in from Walnut Street.

Mr. Lepkowski would like know if the sign can be removed because there is no deaf person on the street. I advised him that will submit to the Safety Committee Chair and he was greatly appreciative of the notification.
