SECTION A - BIDDING REQUIREMENTS - ADVERTISEMENT FOR BIDS

DELETE the sentence "<u>Bid Receipt Date & Time:</u> No later than Wednesday July 27, 2022 at 5:00pm." in Section A, page A-1.1, section 3, and **REPLACE** with the following:

"Bid Receipt Date & Time: No later than Wednesday August 10, 2022 at 5:00pm."

DELETE the sentence "<u>Bid Opening Date & Time:</u> No later than Thursday July 28, 2022 at 2:30pm." in Section A, page A-1.1, section 4, and **REPLACE** with the following:

"Bid Opening Date & Time: No later than Thursday August 11, 2022 at 3:00pm."

SECTION A – BIDDING REQUIREMENTS – ADVERTISEMENT FOR BIDS

DELETE the sentence "The "Building" General Wage Decision (GWD) for Strafford County, NH23, publication date 2/25/2022 applies to this project." in Section A, page A-2.4, paragraph 9, and **REPLACE** with the following:

"The "Building" General Wage Decision (GWD) for Strafford County, NH23, publication date 7/15/2022 applies to this project."

SECTION D – FEDERAL PROVISIONS RULES REGULATIONS AND FORMS – APPLICABLE DOL WAGE DETERMINATIONS

DELETE pages D-20.1 through D-20.6 and replace with attached Applicable DOL Wage Determinations.

SECTION 01 14 19.13 – TEMPORARY BYPASS PUMPING SYSTEM

ADD Section 1.02-D

"All bypass pumping submittals described in Section 1.02-A through 1.02-C must be submitted to the Engineer within two weeks of notice to proceed."

DRAWINGS

SHEET M101 & M102

See Wetwell Vent Piping Revisions (sheet AD-1), attached to this Addendum. Sheet AD-1 supersedes the notes and drawings associated with the wetwell vent piping on sheets M101 and M102 of the original issued contract documents. Sheets M101 and M102 show the existing wetwell vent piping to remain. Sheet AD-1 shows demolition of the existing vent piping in each wetwell, and installation of new PVC piping in a different orientation.

QUESTIONS

- <u>Question:</u> What is the overall NEMA rating of the interior of the proposed pump station?
- Answer: The rating of the pump station shall be NEMA 4.
- <u>Question:</u> Please confirm if any of the underground conduits will be encased in concrete.
- Answer: All conduits shall be direct buried.
- <u>Question:</u> Please confirm that there is a T1, one is not shown on the drawing.
- <u>Answer:</u> There is no T1 transformer.
- <u>Question:</u> Will EMT be a suitable wiring method exposed in the interior of the pump station?
- <u>Answer:</u> All conduits within the pump station shall be RGS.
- <u>Question:</u> Please confirm the exterior type fixtures, the symbols don't match the schedule.
- <u>Answer:</u> Exterior fixtures shall be type SW1.
- Question: Is the portable generator plug outlined on E101 and described on E002, or is the EC to furnish one new assembly to match the existing?
- <u>Answer:</u> There is no existing generator plug on-site. EC to provide new assembly, as described on E101, to match Owner's standard plug. Photos on E002 are of Owner's standard plug at a different pump station.

- <u>Opening:</u> All attendees made introductions and project was summarized. Staff from Weston & Sampson brought attendees inside the fence line of the existing pump station and pointed out equipment/structures to be demoed and the approximate location of the proposed work shown on the contract drawings.

Comments from NHDES:

- This project is receiving CWSRF funding and is therefore subject to typical SRF requirements.
- There are two (2) mandatory forms in Section D of the specifications, DBE Program Subcontractor Participating Forms.
- Normal American Iron and Steel (AIS) requirements apply to this project. This applies to items such as valves, steel, pipe, etc.
- All change orders must be submitted to Andy Morrill for review and approval.
- The CWSRF project sign needs to go up prior to the start of construction.

- Contractors must show good faith effort for DBE (disadvantaged business enterprise). Contractors must document who was reached out to.
- Determinations and De Minimus list in accordance with USEPA and CWSRF.

Comments from Owner:

- To reiterate the contract documents, contractors must maintain access to the Tara Estates mobile home park at all times.
- To reiterate the contract documents, contractors must keep work within the specified work-hours to not unnecessarily disturb the Tara Estates mobile home park.
- Contractor must adhere to the required Construction Scheduling submittal requirements in Section -Construction Scheduling (01 32 16).

Questions from Contractors:


- Please explain the how/where the pump station connects to the gravity sewer.
 - Weston & Sampson answered this question by pointing out the location of the influent gravity sewer manhole, and the approximate locations of the incoming sewer lines and the two gravity pipes feeding each wetwell. Weston & Sampson also added that the FM discharges into the gravity sewer approximately 3,000 feet northwest down Salmon Falls Road.
- Is bypass pumping required or may the existing station stay online during construction?
 - Weston & Sampson answered: The contractor is welcome to keep the existing station online for as long as possible, although bypass pumping will be required as there is significant excavation and work required in the location of the existing underground pump station.
- <u>Closing:</u> Personnel from Weston & Sampson and the Owner concluded the pre-bid meeting, after it was determined that there were no further questions.

The body of each wage determination lists the classification and wage rates that have been found to be prevailing for the cited type(s) of construction in the area covered by the wage determination. The classifications are listed in alphabetical order of ""identifiers"" that indicate whether the particular rate is a union rate (current union negotiated rate for local), a survey rate (weighted average rate) or a union average rate (weighted union average rate).

Union Rate Identifiers

A four letter classification abbreviation identifier enclosed in dotted lines beginning with characters other than ""SU"" or ""UAVG"" denotes that the union classification and rate were prevailing for that classification in the survey. Example: PLUM0198-005 07/01/2014. PLUM is an abbreviation identifier of the union which prevailed in the survey for this classification, which in this example would be Plumbers. 0198 indicates the local union number or district council number where applicable, i.e., Plumbers Local 0198. The next number, 005 in the example, is an internal number used in processing the wage determination. 07/01/2014 is the effective date of the most current negotiated rate, which in this example is July 1, 2014.

Union prevailing wage rates are updated to reflect all rate changes in the collective bargaining agreement (CBA) governing this classification and rate.

Survey Rate Identifiers

Classifications listed under the ""SU"" identifier indicate that no one rate prevailed for this classification in the survey and the published rate is derived by computing a weighted average rate based on all the rates reported in the survey for that classification. As this weighted average rate includes all rates reported in the survey, it may include both union and non-union rates. Example: SULA2012-007 5/13/2014. SU indicates the rates are survey rates based on a weighted average calculation of rates and are not majority rates. LA indicates the State of Louisiana. 2012 is the year of survey on which these classifications and rates are based. The next number, 007 in the example, is an internal number used in producing the wage determination. 5/13/2014 indicates the survey completion date for the classifications and rates under that identifier.

Survey wage rates are not updated and remain in effect until a new survey is conducted.

Union Average Rate Identifiers

Classification(s) listed under the UAVG identifier indicate that no single majority rate prevailed for those classifications; however, 100% of the data reported for the

classifications was union data. EXAMPLE: UAVG-OH-0010 08/29/2014. UAVG indicates that the rate is a weighted union average rate. OH indicates the state. The next number, 0010 in the example, is an internal number used in producing the wage determination. 08/29/2014 indicates the survey completion date for the classifications and rates under that identifier.

A UAVG rate will be updated once a year, usually in January of each year, to reflect a weighted average of the current negotiated/CBA rate of the union locals from which the rate is based.

WAGE DETERMINATION APPEALS PROCESS

1.) Has there been an initial decision in the matter? This can be:

- * an existing published wage determination
- * a survey underlying a wage determination
- * a Wage and Hour Division letter setting forth a position on a wage determination matter
- * a conformance (additional classification and rate) ruling

On survey related matters, initial contact, including requests for summaries of surveys, should be with the Wage and Hour National Office because National Office has responsibility for the Davis-Bacon survey program. If the response from this initial contact is not satisfactory, then the process described in 2.) and 3.) should be followed.

With regard to any other matter not yet ripe for the formal process described here, initial contact should be with the Branch of Construction Wage Determinations. Write to:

2.) If the answer to the question in 1.) is yes, then an interested party (those affected by the action) can request review and reconsideration from the Wage and Hour Administrator (See 29 CFR Part 1.8 and 29 CFR Part 7). Write to:

The request should be accompanied by a full statement of the interested party's position and by any information (wage payment data, project description, area practice material, etc.) that the requestor considers relevant to the issue.

3.) If the decision of the Administrator is not favorable, an interested party may appeal directly to the Administrative Review Board (formerly the Wage Appeals Board). Write to:

4.) All decisions by the Administrative Review Board are final.
