

THIRTEENTH : I give and bequeath to the Trustees of the Trust Funds of the City of Rochester, their successors and assigns, the sum of Fifteen Hundred (\$1,500.00) Dollars, IN TRUST, NEVERTHELESS, for the following purposes:

(a) This Trust shall be known as the Sadie Merriam Fund.

(b) The Trustees shall hold said Trust Fund and the income therefrom shall be spent for the purpose of providing additional books and such other publications as may be required for the Spaulding High School Library or its successor.

(c) The said Trustees shall have the power to sell, convey and dispose of any or all of said property and to invest and reinvest the proceeds thereof, as it may deem best in order to provide income for the purposes of this Trust. The Trust created herein shall be situated, governed and construed by the laws of the State of New Hampshire. The rights, authority, discretions and powers given and granted to the Trustees of said Trust shall not be subject to the control, supervision, direction or jurisdiction of any Probate Court or other Court claiming or having jurisdiction of my Estate, and said Trustees are hereby directed, authorized and empowered to exercise all of the rights, powers, authority and privileges granted to them without license or authority so to do or approval thereof from any Probate Court or other Court claiming or having jurisdiction in the matter.

(d) I hereby nominate and appoint the Trustees of the Trust Funds of the City of Rochester, as Trustees of the Trust created under this Will and direct that they may be permitted to serve without bond except insofar as required by law.


