
Dear Ms. Hubbard:

rights of a qualified beneficiary who request it; and the settlor or a guardian or agent under power of attorney of a settlor who does not have the capacity described in RSA 564-B:6-601. The report shall include a report of the trust property, liabilities, receipts, and disbursements, including the source and amount of the trustee's compensation, a listing of the trust assets, and, if feasible, their respective market values. Upon a vacancy in a trusteeship, unless a cotrustee remains in office, a report must be sent to the qualified beneficiaries who have attained 21 years of age and those who have the rights of a qualified beneficiary by the former trustee. A personal representative, conservator, guardian of the estate, or guardian of the person may send a report on behalf of a deceased or incapacitated trustee."

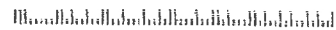
