1. Call to order:

Mr. Libby requested a motion or comments on the minutes for the September 13, 2021 meeting. Mr. Johnson made a motion to accept the September 13, 2021 meeting minutes as presented. The motion was seconded by Mr. Boudreau. The motion passed unanimously.

4. Appeals

4.1 47 Eagle Drive – Kevin Howard

The appellant was not present for the meeting. The appellant requested a sewer credit for some outside watering.

Mr. Johnson made a motion to abate 15 units of sewer at \$7.43 per unit for a total of \$111.45 plus any accrued interest. The motion was seconded by Mr. Barnes. The motion passed unanimously.

4.2 25 Knobby Way – Susan Pike

The appellant was not present for the meeting. The appeal request is for a sewer credit for outside watering.

Mr. Johnson made a motion to abate 13 units for sewer at \$7.43 per unit for a total of \$96.59 plus any accrued interest. Mr. Barnes seconded the motion, the motion passed unanimously.

4.3 10 Washington St. – Bernie Bennett

The appellant was not present for the meeting. The appeal request is for a sewer credit for filling pool and some outside watering.

Mr. Barnes made a motion to abate 40 units of sewer at \$7.43 per unit for a total of \$297.20 plus any accrued interest. Mr. Johnson seconded the motion, the motion passed unanimously.

4.4 203 S. Main St. – Kristina Wentworth

The appellant was not present for the meeting. The appeal request is for a water and sewer for a toilet that was running non-stop.

Based on the Water & Sewer Adjustment Policy Mr. Barnes made a motion to abate 29 units of sewer at \$7.43 per unit for \$215.47 and 29 units of water at \$5.83 per unit for \$169.07 for a total of \$384.54 plus any accrued interest. This is a 1 in 10 year abatement as approved by Ms. Wentworth. Mr. Boudreau seconded the motion, the motion passed unanimously.

4.5 9 Temple Drive – John Almond

The appellant was present for the meeting. The appeal request is for a sewer credit for outside watering.

Mr. Boudreau made a motion to abate 26 units of sewer at \$7.43 per unit for a total of \$193.18 plus any accrued interest. Mr. Johnson seconded the motion, and made a motion to give appellant a 25% hardship credit of \$87.22, motion passed unanimously.

4.6 9 Nature Lane – Norman & Joanne Beaulieu

The appellant was not present for the meeting. The appeal request is for a sewer credit for watering new lawn.

Mr. Johnson made a motion to table the request for more consumption history. Mr. Barnes seconded the motion, the motion passed unanimously.
