1. Call to order:

Mr. Boudreau made a motion to table the appeal until further information is gather that proves the problem is resolved. Mr. Barnes seconded the motion, the motion passed unanimously.

3.2 59 Charles St. – Shannon Curtis

The appellant was not present for the meeting. The appeal is for water and sewer for leaking toilets.

Mr. Barnes made a motion to abate 37 units of sewer at \$8.17 for a total of \$302.29 and 37 units of water at \$6.41 for a total of \$237.17, the water & sewer is a once in ten-year abatement. This decision is pending verbal acceptance of the one in ten-year abatement. Mr. Libby seconded the motion, the motion passed unanimously.

3.3 35 Nutter St. – Alan & Susan Tarring

The appellant was not present for the meeting. The appeal request is for a sewer abatement for an outside faucet.

Mr. Barnes made a motion to abate 19 units of sewer at \$8.17 per unit for a total of \$155.23. Mr. Boudreau seconded the motion, the motion passed unanimously.

3.4 208 South Main St. – Pamela Parsell-Tobin

The appellant was not present for the meeting. The appeal request is for water and sewer abatement for a leaking toilet.

Mr. Barnes made a motion to deny this appeal as the water was used and entered the City sewer system but granted a 25% hardship credit pending proof of repair. Mr. Libby seconded the motion, the motion passed unanimously.
